The Sherman Oaks Neighborhood Council (SONC) has reviewed a proposal for a voluntary night-time curfew at the Van Nuys Airport.

The following motion was presented to the Sherman Oaks Neighborhood Council (SONC) at their regular meeting on Monday, September 9, 2019:

Motion: For the betterment of noise abatement and quality of life, the Sherman Oaks Neighborhood Council (SONC) supports a voluntary night-time curfew at the Van Nuys (VNY) airport of all non-emergency aircraft between the hours of 10:00 p.m. and 7:00 a.m. daily, and additionally from 7:00 a.m. to 9:00 a.m. on weekends and holidays, local time, and authorizes issuing Community Impact Statements and/or letters supporting this position to various elected officials and agencies.

The motion carried unanimously.

Your efforts to support and implement the proposed voluntary night-time curfew, working cooperatively with airport users and surrounding neighborhoods, are appreciated.
