Whereas the selected roads in this Slow Street network are substandard local roads, and whereas none of the selected segments have sidewalks on both sides of the road (some have zero sidewalks), and whereas due to speeding non-local vehicles and narrow/tight clearances, it is dangerous for pedestrians to actively recreate in accordance with social distancing guidelines, be it resolved the Sherman Oaks Neighborhood Council hereby sponsors and requests the creation and implementation of this Slow Streets route between Valley Vista Blvd and Mulholland Dr, east of the I-405 Freeway and west of Stone Canyon, in order to promote active recreation for local residents and neighbors pursuant to the Mayor's Safer at Home order.

d.Area 2-South of the Park Neighborhood

Whereas the roads in this Slow Street network are heavily trafficked to the point of creating a dangerous situation for pedestrians to actively recreate in accordance with social distancing guidelines, through similar speeding traffic seeking to bypass the intended arterial road of Riverside Dr, be it resolved that the Sherman Oaks Neighborhood Council hereby sponsors and requests the creation and implementation of this Slow Streets route between Van Nuys and Hazeltine, north of Riverside and south of the VNSO Park, in order to promote active recreation for local residents and neighbors pursuant to the Mayor's Safer at Home order.
