4) Please describe the purpose and intent of the grant.

Los Angeles Responsible Pit Bull Owners (LARPBO) requests funding to pay for park fees so we can continue to offer low cost group training classes to the community as well as free classes to employees and foster parents of East Valley Shelter. We offer affordable dog training group classes for all breeds at Van Nuys/Sherman Oaks Recreation Center. Our permit is issued for every Saturday morning, with the 1st Saturday of the month from 9:30-12:00 and remaining Saturdays from 9:30-11:00. Fees are paid quarterly at the rate of \$75 the first hour and \$70 per hour thereafter. From June - December, total park fees are estimated at \$3,545.00.

5) How will this grant be used to primarily support or serve a public purpose and benefit the public at-large. (Grants cannot be used as rewards or prizes for individuals)

LARPBO's dog training group classes are held at the park to ensure dog owners are taught the skills to manage dogs in public places and in areas of high distraction. These skills are necessary for dogs to successfully co-exist in the same spaces as the residents, neighborhood visitors, and business patrons of Sherman Oaks. Socially responsible dog owners and well-behaved dogs minimize dog-related risks and aligns to the Council's goal of keeping its neighborhood safe. In addition, dogs that are well-behaved are less likely to be surrendered to the overburdened City shelters.


Dear Applicant:
