Comments from the public on other matters not appearing on the agenda that are within the Committee's jurisdiction will be heard during the Public Comment period. Public Comment is limited to 2 minutes per speaker unless adjusted by the presiding officer.

4. PRESENTATION – **Map Your Neighborhood**TM – Kristin Sales of Prep Connect, Inc. works to make neighbors empowered and self-sufficient in the event of an emergency. Some things discussed:

- Courses are divided: Connect, Discuss, Explore, Apply, Simulate
- There are 9 steps to take after a disaster. The first 6 steps are for the individual/ family/ home. The next 3 steps relate to survival of your neighborhood and forming teams.
- MYN teaches how to respond during the first hours of a disaster.
- A neighborhood is defined as 15-20 houses.
- "Golden Hour" is a term used by emergency responders relating to Hour One of a disaster. This is the time of most importance to save lives and property. MYN teaches what people need to do in those first moments.

Disaster vs Emergency

- Emergency is when we call 911. Problem is out of control & needs Police, fire, utilities.
- Disaster is when 911 is overloaded and neighbors become the first responders.

ONGOING RADIO COMMUNICATIONS PRACTICE OPPORTUNITIES:

Weekly Walkie-Talkie Radio Check-In: Every Sunday at 10am: Channel 20 (or Ch 17 if 20 is busy), we check-in around the Valley to see how far our voices can be heard. We practice checking-in, moving locations around the home until someone can hear us. Simple radios are a good source of emergency communication with your immediate area which could help if we experience a valley-wide disaster. The PSC suggests you pull-out a walkie, put in fresh batteries, and listen to next Sunday's net to see if you can hear anyone.

Weekly Sunday Morning Lake Balboa Amateur Radio Net: Every Sunday at 9am on Simplex 145.570 we have a weekly net for Ham Radio Operators transmitting around the SF Valley and beyond. It is a formal, but friendly, net where information is exchanged on a variety of topics. It is especially great net for NEW Hams.
