#### 4. Introductions & City Updates – Committee, City Officials and Staff:

#### Ryan Ahari:

-Noted Christy Adair's award for all her work with the community.

-Library Square Update

-Street Lights-lights added in some areas and need more light in other areas.

-CIRCLE (Crisis and Incident Response through Community Led Engagement)-divert non-

emergency calls to homeless in front of businesses-1 million invested in the Ventura corridor.

Attendee Question-How can more light poles be added in areas that need lights?

**Ryan-** Light poles cost about 20K. CD4 is trying to find alternative options instead of neighbors paying for 1 light pole. One option is DWP's Utility Lighting program which installs lighting on existing DWP wooden utility poles. Alert CD4 office if lights are dim or defective.

Susan- long wait times for 877-ASK-LAPD.

**Barbara** - The 911 & non-emergency operators are the same personnel, rotated depending on internal needs for the day. Currently, they are short-staffed. They are hiring, but the process takes a long time. It's paid on-the-job training with benefits, and training takes about a year.

Attendee Comment (Alan Scher) - CIRCLE is currently only implemented in certain zip codes.

**Ryan-** Let CD4 know if there is a location that needs attention.

Jesse- CIRCLE is serviced by mental health professionals rather than police.

Susan- Trees in the park need trimming. Branches falling on people.

**Ryan-** Currently only a 14-person park maintenance crew & is short staffed to address all maintenance needs quickly.

Attendee Comment- Attendee-pool of water in some areas of park.

Ryan- Park Maintenance Crew responsible for park

**Penny J-** Announced SONC Public Safety Committee Website information for Youtube videos. Ryan's past presentations on streetlights, etc are on the website for viewing.

Susan- Thanked Starbucks Managers (Carina & Francis) for hosting.

### 5. <u>Sherman Oaks Senior Lead Officer Updates</u>

**SLO Saldana-** Covers South part of Sherman Oaks, property crimes, vehicle break-in burglary South of the Ventura Bl, some businesses had smash and grab break-in. Crime incidence is similar to last year, with a slight rise this year.

**SLO Romo-** Covers area Northern Part of Sherman Oaks-mostly property crime, catalytic converters, mall incidents at Bloomingdales and Macy's (one person arrested). Be a Good witness, and call for assistance. Don't interact & compromise your safety.

# 6. <u>Public Comments – Comments by the public on non-agenda items within the Public Safety Committees Jurisdiction:</u>

Attendee (Francis) Starbucks Manager- Situation at location has been getting better in the last 5 months. Long wait for non-emergency number.

**SLO Saldana-** Low staffed, less 600 911 operators, no other number currently, not enough staff. City is in the process of hiring.

SLO Romo- Long wait times is the biggest complaint from neighborhoods.

Attendee Question/Suggestion- Where do parking violations fees go? Suggested using parking violation funds for additional support resources. Who do you call for parking violations such as people parking in the red zone, fire hydrant, blocking driveways, etc?

SLO Saldana- Call DOT for parking violation issues.

SLO Romo- Also call SLO, we will try to help with any parking enforcement.

Attendee Comment (Stacy) - Asked SLOs to come to the full Neighborhood Council Board Meetings, then asked the officers if they know what the Hatch Act-Law is? She told them it's a federal law prohibiting law enforcement officers from talking about politics while on duty. She states violations are a federal offense.

Attendee Question (Bill)- How can you address squatters? Will no trespassing sign help?

**SLOs Saldana/Romo-** Put a No Trespassing sign on property. Owner of the property can sign a Trespass Arrest Authorization and have it on file with the police department.

**Barbara-** You can tell the 911 or non-emergency operator during the call that you would like to meet with the responding officers or ask that the responding officers call you.

Attendee Question- So many people running red lights. Is there a plan to increase monitoring?

SLO Saldana- No plan in place currently because there is a shortage of officers.

**Penny J-** Question referred to Ryan Ahari for later- How are you going to mitigate traffic when Citrus Commons opens on Riverside/Van Nuys for new traffic. Can there be White Gloves directing traffic at the congested intersection?

SLO Saldana- DOT responsibility, and question for DOT.

### 7. <u>Committee Response to Public Comments:</u>

Attendee Comment (Alan Scher) - Need Volunteers to help LAPD, Announced Sean Kurzweil, Susan Collins are on CPAB Committee. Meet with the police captain 1x/mo. CHP needs volunteers, Police station needs donations.

**Attendee Comment (Jeffrey Hartsough) -** Neighborhood Council elections is on June 22nd. The Summer Movies in the Park starts June 24th.

Attendee Comment- Taxes are increasing, but still not enough services provided. It seems the population doesn't respect law.

Attendee Comment (Lucie Volotzky)- The police officers need community support. We cannot defame all of the police. Announced she is running for State Senate.

**Cissy-** Senior Services for age 50+ available at the Sherman Oaks Adult Center. Valley Intercommunity Council offers free services for seniors such as meals on- site (\$3 donation or free), meal delivery for homebound seniors, classes, case management, social activities, and

**Christy-** LAFD Community Emergency Response Team (CERT)-RSVP at <u>www.CERT-</u> <u>LA.com/eventbrite</u>. Free 7 topic class by LAFD. Join classes at various locations at your convenience. You can take the classes out of order. # **ONGOING RADIO COMMUNICATIONS PRACTICE OPPORTUNITIES:**

Weekly Walkie-Talkie Radio Check-In: Every Sunday at 10am: Channel 20 (or Ch 16 if 20 is busy), we check-in around the Valley to see how far our voices can be heard. We practice checking-in, moving locations around the home until someone can hear us. Simple radios are a good source of emergency communication with your immediate area which could help if we experience a valley-wide disaster. The PSC suggests you pull-out a walkie, put in fresh batteries, and listen to next Sunday's net to see if you can hear anyone.

Weekly Sunday Morning Lake Balboa Amateur Radio Net: Every Sunday at 9am on Simplex 145.570 we have a weekly net for Ham Radio Operators transmitting around the SF Valley and beyond. It is a formal, but friendly, net where information is exchanged on a variety of topics. It is especially great net for NEW Hams.
