Note that the substantive nature of ED-1 is under review by the PLUM and Vision Committees. A discussion and/or potential motion concerning City Hall's accelerated review and approval of CF23-0623 within a two week period (6/13/23 to 6/27/23), which does not provide sufficient time for NC and community review. History:SONC issued a letter to City Council and the Councilmember for our Council District 4 concerning attendance, quorum, and public comment issues at LA City Council effectively emanating from the perception that City Council does not listen to its constituents. See: Letter from SONC to CD4-Attendance/Quorum/Public Comment at City Council (7/12/23). History: SONC adopted a Community Impact Statement (CIS) position of Against in CF20-0866 (IndependentReport/ Demonstrations Against Police Brutality and Racism/LosAngeles Police Foundation/Donation) concerning an LAPD Foundation donation. In opposing LAPD's acceptance of a donation from Foundation of \$350,000 to investigate its own actions, SONC adopted the following statement: "SONC further notes that City Council scheduled and approved CF 20-0866 in such short order as to prevent adequate time for Neighborhood Councils to review this item, and expresses its disapproval of such tactics to bypass local review."

MOTION: Whereas effective Neighborhood Council operations require 60 to 90 days to consider potential motions and council files;

And whereas CF 23-0623 was acted on by Los Angeles City Council in a period of fourteen days which is not sufficient for neighborhood councils to fully consider the item; And whereas a Community Impact Statement is required to make use of Neighborhood Councils' maximum speaking period allocated during committee and general meetings; Therefore, The Sherman Oaks Neighborhood Council (SONC) requests that the Los Angeles City Council refrain from voting on pending motions and/or council files until Neighborhood Councils have been granted at least 60 but up to 90 days to bring items for consideration to committee/board meetings, hear public remarks, and potentially file a Community Impact Statement.
