a. Solar-Powered Lighting and Copper Theft from Street Lights. Presented by Lindsay Imber. CF 24-0036. Solar-Powered Lighting / Copper Wire Theft / Streetlight Replacement.

Draft Motion: The Sherman Oaks Neighborhood Council (SONC) supports CF 24-0036 pertaining to the installation of solar-powered lights or conversion to solar when the Bureau of Street Lighting is responding to lighting outages attributed to copper wire and power theft incidents, or other maintenance issues.

SONC also supports the Bureau's solar lights pilot program as part of a potential move in the city toward solar street lighting, where available.
