The Sherman Oaks Neighborhood Council supports the ED 1 Ordinance only if amendments are added to the draft ordinance file CF23-0623. We support the guidelines sent by United Neighbors to the PLUM committee, with a particular focus on the importance of the following amendments:

- 1. Limit the number of waivers and off menu incentives to a total of 6;
- 2. Requiring rear 15' setbacks to allow for trees to grow and storm water to be captured;
- 3. Preventing post-development conversion of nonresidential spaces to market rate units;
- 4. Protecting R 1, HPOZs and Historic Districts in their entirety;
- 5. Ensuring that substandard streets/high-fire zones do not qualify for ED-1 fast track approval;
- 6. Requiring ED 1 projects to meet minimum Tier 2 TOC qualifications. Projects that don't qualify under ED 1 would need to go through discretionary approval.
