a. City Council Motion to Suspend Brown Act Due to Emergency

CF 25-0647-S1

POSITION: Against Unless Amended

DRAFT MOTION: The Sherman Oaks Neighborhood Council (SONC) strongly opposes Council File 25-0647-S1. While we support the expediting of holding meetings to address emergencies arising from federal agencies acting unlawfully in Los Angeles, and threatening the safety and wellbeing of immigrant communities, we oppose the use of emergency provisions as an excuse to disregard the Brown Act.

In the Council File, the City Council invokes Government Code Section 54956.5(b)(1) that says, "in the case of an emergency situation involving matters upon which prompt action is necessary due to the disruption or threatened disruption of public facilities, a legislative body may hold an emergency meeting without complying with either the 24-hour notice requirement or the 24-hour posting requirement of Section 54956 or both of the notice and posting requirements."

The motion then states that the purpose of invoking said code is "in order to enable the Council to have emergency meetings without complying with the Brown Act."

Section 54956.5(b)(1) is part of the emergency provisions of the Brown Act. While it is the prerogative of the City Council to invoke this provision; it is not within the City Council's scope of

authority to grant itself impetus for non-compliance with the Brown Act, including its generous emergency provisions.

SONC requests that the City Council vote to reconsider this motion to remove language indicating planned non-compliance related to the Brown Act; and requests a report from the office of Council District 4 (Raman) to provide SONC and our stakeholders reasonable justification as to the Council Member's vote on this item.

b. Rental Market Price Gouging Complaints After Wildfire Event.

We ask that the motion be amended to request collaboration from the Chief Legislative Analyst, and the Los Angeles Housing Department relating to this matter, that appropriate recusals take place, and third party independent investigations of price gouging offenders recommended where necessary.

DRAFT MOTION: *The Sherman Oaks Neighborhood Council (SONC) supports City Council's motions that considers creation of policy to require LAPD officers to verify the identity of any individual claiming to be a law enforcement officer, including Federal/State/Local, and to increase the penalties for the impersonation of such officer and/or harassment or intimidation of an individual or property under false pretenses, such as impersonation. There is absolutely no place in our society for masked individuals claiming to be law enforcement refusing to identify themselves when able and appropriate, which could and has led to individuals impersonating officers unlawfully harassing, abusing, threatening, or committing crimes against these victims, as well as misconduct by actual officers acting outside the scope of their employment, thanks in part to the avoidance of accountability risk due to anonymity under mask. This motion seeks to provide relief for our concerned and scared constituents, notably the immigrant community which is disproportionately affected by these illicit tactics. It is important to hold all parties accountable in a contact, detention, arrest, and/or criminal situation, and the aggressive conduct alongside an appearance of impropriety necessitate this reasonable and just action.*

As a result of minority scapegoating, a manufactured culture war, and willful disregard of science and academia that has led to a hateful, bigoted, and discriminatory atmosphere in this country, many LGBTQ+ individuals face challenges accessing healthcare, housing or shelter, and other vital services.

The Lemkin Institute, founded to make sure the atrocities of the Holocaust never happen again, issued a "Red Flag Alert for Genocide" specifically in regard to laws and actions in the United States targeting transgender people.

It is imperative the City act to protect this vulnerable minority group which is under attack through discriminatory legislation and unlawful executive actions.

**As stated in a prior motion, SONC also requests City Council use one initialism for this community—terms LGBT, LGBTQ+, LGBTQI+, and LGBTQIA+ (Lesbian, Gay, Bisexual, Transgender, Queer, Intersex, and Acesexual) all appear in the Council File Management System to describe this population, which hinders searchability when requesting past and present council motions. The plus-sign is meant to include all applicable identities; standardizing this initialism will increase efficiency and accuracy. For the purpose of this motion, SONC uses "LGBTQ+" for this community.*
