DRAFT MOTION:

The Sherman Oaks Neighborhood Council requests the office of Council District 4 (Raman) in conjunction with the Department of Transportation and Parking Enforcement to perform oversight and seek remedies relating to the following persistent issues regarding parking:

*Double parking for loading, pick-up, drop-off, etc.
Parking along red-curbs and in fire lanes.
Parking on sidewalks.
Parking in driveway entrances in a way that blocks sidewalks
Parking at bus-stops
Idling while parked
Congestion during school drop-off / pick-up*

Some potential solutions may include but aren't limited to:

- *Create white-curb load-zones
3-minutes for pick-up/drop off
10-minutes for load/unload*
- *Augment the number of accessible/handicap street parking spaces*
- *Increased enforcement of parking violations*
- *Increase fines and penalties for violations by courier / delivery services
[Amazon, FedEx, UPS, etc.]
Enhanced programs to report parking violations
rewards for reports that result in fines*
- *“Park & Walk”
low or no-cost public parking garages in dense, high-traffic areas with limited parking options*
- *Public-Private-Partnerships with owners of private business with large parking lots / structures to allow for public usage during hours of non-operation*
- *Minimum parking requirements for new construction that isn't 100% affordable housing in areas with limited street parking*

SONC encourages creative solutions to mitigate parking issues to serve the needs of the community, enhance public safety, and maintain quality of life for residents and stakeholders
