- **b. Motion: CF 24-1085-S1. Transfer of \$150,000 from Homeless Services Account to Police Fund**
- **Position: Oppose.** The Sherman Oaks Neighborhood Council (SONC) stands in firm opposition to transferring any funding from Account 0619 - Homeless Services Account to cover overtime for the Los Angeles Police Department (LAPD). While the city remains under an active emergency order relating to homelessness, in the wake of revelations on gross mismanagement of funds by the Los Angeles Homeless Services Authority, it's unconscionable that any funding would be transferred out of accounts dedicated toward alleviating the suffering of unhoused residents. The LAPD's budget accounts for 23.6% of the total City budget for Fiscal Year 2026; the largest operating budget for any city department or agency. The funding dedicated to housing and homelessness is a small fraction of what is already dedicated to the LAPD. If CD5 is in need of additional funding for police that cannot be accounted for within their current budget, Councilmember Yaraslovsky, and other Councilmembers supporting this motion, should find that funding within their own office's operational or discretionary budgets rather than removing funding from an account that should be utilized to address the ongoing crisis relating to homelessness.

Motion: Suggested Charter Addition – Community Planning and Land Use Authority Purpose: To preserve the integrity of Community Plans, maintain elected accountability in land use decisions, ensure professional oversight, and promote coordinated, transparent, and efficient planning and building administration**

A. Community Plans

- The existing 35 Community Plans shall remain in effect, recognizing neighborhood diversity, character, geography, transit access, and history. Additionally, we suggest expanding them to 70 to better reflect individual identity and needs. Each Community Plan shall be updated at least every 20 years.

B. Floor Area Ratio (FAR)

- All Charter references to FAR are removed. Recode LA development standards shall govern citywide.

C. Project Review

- Projects fully conforming to Re Code LA standards shall receive ministerial approval and proceed directly to permitting. Deviations require discretionary review per ordinance. Charter Section 245 is retained, preserving City Council authority to review or veto discretionary actions.

D. Time Limits and Ordinance Review

- Existing Charter time limits for General Plan review are retained. Other procedural timeframes may be set by ordinance. Required review of proposed ordinances by the elected City Attorney is retained. A nonelected city attorney may not be responsive to the public.

E. Council Accountability

- Councilmember authority over land use decisions and appeals is retained. Consolidation under administrative bodies alone would remove elected oversight and reduce public accountability.

F. Public Review

- Public review remains required for all discretionary projects. While Re Code LA will reduce discretionary cases, public and Council input shall be preserved where review is required.

G. Planning Commissions

- The City Planning Commission shall consist of nine members, at least five with five or more years of senior professional experience in architecture, landscape architecture, planning, engineering, or land use law. Each Area Planning Commission shall have five members, at least three with five or more years of senior professional experience in architecture, landscape architecture, planning, engineering, or land use law.

H. Community Development Department

- A Community Development Department is established. Led by a qualified manager appointed by ordinance. It shall coordinate the Planning Department, Department of Building and Safety and other departmental reviewers for consistent, transparent decision-making. It shall promote efficiency, accountability, and timely inter-departmental service delivery.

Suggested Charter Addition – Board of Infrastructure

Purpose: A Board of Infrastructure is created to consolidate and coordinate management of the public right-of-way and related infrastructure. It shall replace the current system of fragmented departmental authority that causes delay, inefficiency, and lack of accountability.

A. Composition and Jurisdiction.

- The Board of Infrastructure shall include representation from, at minimum: the Port of Los Angeles, Los Angeles International Airport, Department of Public Works, Police Department, Los Angeles Unified School District, Department of Water and Power, Los Angeles County Metropolitan Transportation Authority (Metro), and Department of Recreation and Parks. Each participating entity shall have an active role in the coordinated operation, maintenance, and improvement of City infrastructure.

B. Annual Reporting.

- Each entity listed in Subsection (A), and any others designated by the Board of Infrastructure, shall submit an Annual Report on Growth and Construction identifying all projects in progress or completed during the preceding year. Reports shall be submitted no later than the end of each fiscal year.

C. Powers and Duties.

- The Board of Infrastructure shall: Oversee and coordinate planning, construction, maintenance, and management of public infrastructure and the public right-of-way; Review and integrate submitted Annual Reports; Identify overlaps and inefficiencies and issue recommendations to the Mayor and Council; Ensure that infrastructure decisions align with long-term citywide goals.

D. Capital Improvement Plan.

- The City shall maintain a Capital Improvement Plan (CIP) under the direction of the Board. The CIP shall include a rolling five-year capital budget and a fifty-year planning horizon establishing priorities for maintenance, replacement, and expansion of infrastructure necessary for growth, safety, and sustainability.

Suggested Charter Addition - Parks Funding and Protection

- The City shall establish and maintain a dedicated source of funding for the acquisition, development, maintenance, and improvement of public parks and recreational facilities with a stated goal of ensuring the growth and availability of parks stays consistent with the growth of population in an area. Public parks and designated open spaces shall not be sold, leased, or converted to residential or commercial housing uses, except by approval of two-thirds of the voters at a Citywide election. The City shall give priority to the preservation and expansion of parkland as neighborhood density increases.

Suggested Charter Addition - Protection of Low-density Residential and Historic Districts

- The City of Los Angeles hereby declares the preservation of single-family residential zones and designated historic districts as fundamental to the character, stability, and livability of the City. No action of the City shall diminish, eliminate, upzone, or otherwise alter the protections of such zones and

districts except by a supermajority vote of four fifths of the City Council following extensive public hearings.

Suggested Charter Addition - Defense of Local Zoning Authority

- The City Council, the Mayor, and the City Attorney shall have a mandatory duty to defend and uphold the City's zoning authority against any proposed State law or regulation that seeks to preempt, override, or otherwise diminish local zoning and land-use controls, including actions taken by the State under a declared emergency. The City shall immediately and aggressively pursue all available legal, legislative, and administrative remedies to protect the integrity of its Charter-based zoning powers. City resolutions relating to pending State legislation must be heard and resolved within 90 days, or the resolution is automatically approved. The Planning Department shall have the authority and resources to review and evaluate the impact of proposed State legislation.

12. Public Safety Motions & Committee - Christy Adair & Susan Collins, Co-Chairs. Meets on the 2nd Tuesday of the Month

a. Motion: The Sherman Oaks Neighborhood Council supports the request of residents, business owners, and other stakeholders for action to address chronic unsafe and unsanitary conditions within the Colbath–Ventura–Stern “U” (extending to Moorpark St.), with Ventura & Stern as the epicenter—particularly Stern’s Draperies and the Stern Ave. sidewalk of the Ventura & Stern Shopping Center.

Area of Concern (“the U”) includes:

- 13949 Sherman Oaks Plaza & Chase Bank
- 13925 McDonald’s (Ventura Blvd.)
- 13901 Ventura & Stern Shopping Center (incl. 7-Eleven)
- 13861 Stern’s Draperies
- Residences on Stern and Colbath between Ventura and Moorpark, especially 4318 Stern Ave.

Background and Current Conditions. Residents and businesses formed the Ventura & Stern Coalition in 2021 and temporarily drove out a narcotics operation that was operating from Stern’s Draperies (13861 Ventura Blvd., Sherman Oaks, CA 91423). By 2025 (or earlier) the narcotics operation returned, and the area now endures recurring narcotics-based encampments; open-air narcotics use and dealing; biohazard accumulation (used needles, urine, feces) and noxious fumes; harassment, intimidation, episodes of drug-induced psychosis and indecent exposure; trespass into garages and storefronts; blocked sidewalks and ADA barriers; late-night disturbances; fire hazards and combustible debris; neglected vegetation and dead/falling trees; graffiti and vandalism; and repeated thefts/shoplifting—conditions that prevent residents from living normal lives and make it difficult for nearby businesses to function.

Why is the problem acute here? An entrenched narcotics operation has identified the corridor as lucrative and is effectively allowed to operate from Stern’s Draperies, with onsite use tolerated; it exploits unhoused

individuals as customers, crew, and cover, using shopping carts, bikes, and backpacks as dealer tools. The coalition has amassed visual evidence and submitted it to CD4 and LAPD. Compounding this are persistent property management failures at Stern's Draperies and a lack of adequate, sustained City action, including inconsistent enforcement, cleanup, and follow-through.

Impacts on residents and businesses. There are significant access barriers for vulnerable populations, including seniors, children, and people with disabilities in the apartments and condos on Stern Ave. A family with young children moved out last month because of the crime and degradation. A senior who does not drive will not leave her apartment at night; another resident reports driving her grandchildren 358 feet to McDonald's to avoid the threat; and a resident with an adult son with special needs chose this location for walkable access to services, but criminal activity and frequent drug-induced psychosis mean safe access is limited or unavailable. The owner of 4318 Stern Ave. reports multiple move-outs due to fear and degraded conditions, creating financial strain and undermining safety for remaining tenants. Problems typically originate on the north or west side of Stern's Draperies or along the east sidewalk of the Ventura & Stern Shopping Center and then spread to neighboring properties. The Ventura & Stern Shopping Center tenants and adjacent McDonald's are family-owned businesses struggling to function as employees feel threatened and customers stay away.

Documentation. These issues have been repeatedly documented and reported to LAPD, LAFD, Councilmember Raman's office, the City Attorney's Office, and SONC; nevertheless, no sustainable remedy has been implemented. Residents and business owners have provided extensive emails, photographs, and other evidence of ongoing conditions, including reports of a repeat offender (subject to a stay-away order) and barriers to ADAcompliant safe passage.

Therefore, SONC requests:

- 1. Nuisance Abatement: That Councilmember Raman, Mayor Bass, and City Attorney Hydee Feldstein-Soto work in collaboration with the Ventura & Stern Coalition and initiate proceedings to deem Stern's Draperies a nuisance property, with an enforceable plan and timeline for abatement.
- 2. Public Safety Resources: That Councilmember Raman, Mayor Bass, and the City Attorney provide additional resources to LAPD for focused patrols and targeted enforcement in this micro-zone, and coordinate with the District Attorney's Office to pursue appropriate actions for repeat offenders so residents and businesses can experience sustained relief and restored access to public spaces.
- 3. Sanitation & Biohazard Abatement (LASAN): That LASAN implement a sustained sanitation plan for the corridor—designating the Ventura & Stern hotspot for recurring (e.g., weekly) biohazard and debris removal, sharps pickup, pressure washing, and graffiti abatement (in coordination with StreetsLA)—with priority service at Stern's Draperies, the Ventura & Stern Shopping Center, McDonald's, adjacent alleys/bus stop areas, and heavily impacted apartment buildings and condos on Stern such as 4325, 4333, 4334 and especially 4318 Stern Ave. LASAN should publish the service cadence to SONC and CD4 and coordinate scheduling with LAPD for cleanup safety.
