IN CONFORMITY WITH THE OCTOBER 6, 2023 ENACTMENT OF CALIFORNIA SENATE BILL 411 (PORTANTINO) AND LA CITY COUNCIL APPROVAL ON NOVEMBER 1, 2023, THE SHERMAN OAKS NEIGHBORHOOD COUNCIL GREEN & SUSTAINABILITY COMMITTEE MEETING WILL BE CONDUCTED VIRTUALLY.

When prompted by the presiding officer, to provide public input at the Neighborhood Council meeting the public will be requested to dial *9 or use the Raise Hand option, to address the Board on any agenda item before the Board takes an action on an item. Comments from the public on agenda items will be heard only when the respective item is being considered.

Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Board meeting. If you are on Zoom, you will see a timer graphic indicating your time remaining to speak. If you are on a telephone, you will be told when 10 seconds remain in your allotted time. Public comment for this meeting will be heard during each eligible agenda item.

SB 411 Updates:

If a Neighborhood Council has a quorum of board members in a physical location, board members who wish to join the meeting via teleconferencing must adhere to AB 2449 rules and regulations. If a Neighborhood Council does not have a quorum of board members in a physical location, they must adhere to SB 411 rules and regulations.

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments

using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time.

Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.

(i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph , to provide public comment until that timed public comment period has elapsed.

(ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.

(iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

Motion: Green & Sustainability Committee request that when SONC purchases and obtains logoed merchandise to be used as giveaways to the public at events such as the Movies in the Park, the Spring Tree Giveaway, and the Sherman Oaks Street Fair that these items be made of biodegradable or recycled materials whenever possible, and also be chemical free and free of harmful materials to living organisms. The items should always include labels that indicate whether they are made of recycled materials, whether they are safe, or present potential hazards. We prefer that plastic items such as beachballs and glow sticks only be acquired if they meet these simple requirements and so that they will not wind up in landfills for the rest of eternity, or present a hazard to sea life should they wind up in our oceans.

Temperature Regulation:

Shade trees reduce ambient temperatures by blocking direct sunlight and releasing moisture through transpiration, creating cooler and more comfortable environments across neighborhoods.

Energy Savings:

Well-placed shade trees help lower cooling costs for homes and businesses by reducing heat absorption, decreasing reliance on air conditioning, and ultimately reducing utility expenses.

Wildlife Habitat:

Trees play a vital role in supporting local biodiversity by providing shelter, nesting sites, and food sources for birds, insects, and other wildlife.

Air Quality Improvement:

Trees absorb carbon dioxide and airborne pollutants while releasing oxygen, contributing to cleaner, healthier air for residents.

Soil Conservation:

Strong root systems stabilize soil, reduce erosion, and enhance groundwater retention, improving the health of local ecosystems.

Aesthetic and Community Value:

Shade trees add beauty, structure, and character to streetscapes and public spaces, enriching the visual appeal and overall livability of our neighborhoods.

Climate and Community Resilience:

Investing in shade trees and shade infrastructure strengthens the City's ability to adapt to rising temperatures, supports long-term sustainability goals, and creates safer, more resilient communities.
