IN CONFORMITY WITH THE JANUARY 1, 2026 ENACTMENT OF CALIFORNIA SENATE BILL 707 (DURAZO) AND LA CITY COUNCIL FILE 23-1114, THIS SHERMAN OAKS NEIGHBORHOOD COUNCIL MEETING WILL BE CONDUCTED VIRTUALLY.

Making Public Comments During This Meeting: Every person wishing to address this Committee must dial 1-669-900-6833, and enter Webinar ID 81168943092 and then press # to join the meeting. When prompted by the presiding officer, to provide public input at the Neighborhood Council meeting the public will be requested to dial *9 or use the Raise Hand option, to address this Committee.

Public Comments on Agenda Items: Comments from the public on agenda items will be heard only when the respective item is being considered, and prior to voting.

General Public Comments (Non-Agenda Item): Comments from the public on other matters not appearing on the agenda that are within the Committee's jurisdiction will be heard during the Public Comment on Non-Agenda Items period. Under the Brown Act, the Committee is prevented from acting on a matter that you bring to its attention during this General Public Comment period; however, the issue raised by a member of the public may become the subject of a future meeting. Public comment is limited to one minute per speaker, unless adjusted by the presiding officer of the Committee.

Disruption to Meeting: In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1. California Government Code Section 54953.8(b)(3).

Comments Not Required in Advance: The legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time. California Government Code Section 54953.8(b)(4). public comment

through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate. California Government Code Section 54953.8(b)(5),

Timed Public Comment Period: A legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to paragraph (5), to provide public comment until that timed public comment period has elapsed. California Government Code Section 54953.8(b)(6)(A),

Public Comment Heard Per Item (non-timed): A legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to paragraph (5), or otherwise be recognized for the purpose of providing public comment. California Government Code Section 54953.8(b)(6)(B).

A motion to approve the expenditure of up to \$4,900.00 for SONC’s Summer Series Movies in the Park (MITP) screening at the Van Nuys Sherman Oaks War Memorial Park on Saturday, June 27, 2026. Funds will go towards film rental/licensing fees, projection services, and family friendly activities. Funding will also be used to acquire SONC branded promotional materials, SONC printed materials, and event logistical support.

7. Motion from the floor – Support Council File 26-0002-S8, AB 1633 (Haney)/Private Detention Facility Tax Law/ Corporate Profiteering /ICE Funded Immigration Detention Centers (Hernandez - Blumenfeld - Jurado - Padilla - Rodriguez - Soto-Martinez)

The motion made by LA City Council is to include Support for State Assembly Bill (AB) 1633 in its 2025-2026 State Legislative Program Support. The legislation will create the Private Detention Facility Tax Law and thus curb corporate profiteering from ICE-funded immigration detention centers in the state of California. The privatization of prisons in the United States has devastating effects on incarceration rates, sentence lengths, and the costs of imprisonment, which becomes a taxpayer burden. ICE has been given a budget of \$45 Billion dollars to fund the building of new immigration detention centers that will house both adults and children. Privately operated companies have been an important partner for ICE as the US government carries out its immigration agenda. ICE contracts with corporations to build and operate these facilities and to transport undocumented individuals who are in custody. If these private corporations did not exist, it would be difficult for the federal government to execute its plans. The two largest private prison corporations reported significant profits during the recent earnings calls. These types of operations have been highly criticized for keeping detainees longer than reasonable in efforts to increase their profits.
