Motion:

The Sherman Oaks Neighborhood Council supports the Citywide Implementation **Option C2**, which would delay implementation of SB 79 in low-resource areas, high fire severity zones, HPOZs, and low sea level areas until 2030. Option C2 also proactively incentivizes qualifying single-family and low-density neighborhoods to allow three-story apartment buildings with 4–16 units, rather than the seven-story apartment buildings mandated under SB 79. This option would still permit SB 79–compliant developments at existing rail stations.

However, our support for Option C2 is expressly conditioned on the following:

1. The proposed changes must be clearly defined as an incentive program, not a rezoning or upzoning, and must be explicitly structured so that the incentives can be withdrawn if SB 79 is amended or repealed.
2. All existing setback requirements of the underlying zone must be maintained.
3. All affected property owners and residents must receive mailed notification of the proposed changes to ensure robust outreach beyond online notices.
