Summary of Proposal

- Fashion Square has fewer restaurants than other nearby shopping centers; this is due to an outdated, more than 20-year old zoning condition limiting the shopping center to 3 sit-down restaurants.
- A proposed vesting zone change would allow 8 additional sit-down restaurants, with a conditional use permit for alcohol.
- Restaurants would be converted from existing tenant and back-of-house space; no building expansion is proposed.
- No outdoor patios along Riverside Drive are proposed.
- No significant traffic impacts.
- No significant environmental impacts (MND); an MND is being prepared and will be circulated for public review.
- No reduction in existing parking supply or existing parking requirements is proposed.
- Westfield has met with many constituents in the community and will continue to meet with any community members who are interested in learning about or discussing the proposal.
